WHAT ARE THE BRITISH BANK AWARDS?

The British Bank Awards are run by Smart Money People, the UK's dedicated financial services review site. The awards were launched in 2015 to put consumers at the heart of the industry, as all winners are determined using data collected by Smart Money People's reviews, ensuring that companies who win are those who really deliver on great products and customer service.

In 2022, after 13 weeks of voting, over 81,000 consumers helped to decide the winners in the awards through the power of their reviews. Businesses compete hard to win in the British Bank Awards, and are keen to promote their achievements through press coverage, and marketing campaigns to their customer base.

Award categories span the vast range of the banking sector, with specific categories for innovation, new entrants to the market, ethical providers, influencers, and many more. Each year voting in the awards culminates in a celebratory awards event in the heart of London. Our 2022 event sold out, with hundreds of guests coming together for an evening of networking, celebration and entertainment.

WHO'S BEHIND THE BRITISH BANK AWARDS?





FAQS

We've put together some frequently asked questions to help answer common queries.



WHEN DOES VOTING COMMENCE?

Voting opens on 9th January 2023 and closes 11:59PM on 11th April 2023.

Between the 9th January and midnight on the 11:59PM on 19th March 2023, customers can vote for any firm they choose and this voting will determine our finalist shortlist.

On 20th March 2023 we'll confirm the finalist shortlist, based on the voting to date.

Customers can continue to vote for these finalists until voting closes on at 11.59PM on 11th April 2023. All votes during the period 9th January to 11th April will be counted for finalists.



HOW CAN MY FIRM BE NOMINATED?

Please contact us by emailing events@smartmoneypeople.com to register your interest. We'll let you know the next steps and if you're a consumer facing provider, we'll make sure you have a review page on the Smart Money People website.



HOW MUCH DOES IT COST TO TAKE PART?

There's no entry cost for firms to take part.



WHAT IS THE VOTING PROCESS?

Your firm will need to register and have a review page on the Smart Money People website. You will then be supplied with a link to provide to your customers, who can vote for your firm in specific product categories. Customers can also vote directly via the Smart Money People website, leaving feedback on a product. That's it! From landing on the page, to submitting their vote, it should take two minutes or less.



WHAT PERSONAL DATA DO WE CAPTURE?

We ask voters their name and to provide an email address. This helps us to validate votes and to communicate with the winner of our prize draw. We do not capture any account specific information, nor do we share this data with third parties. We are registered with the ICO: ZA190919



WHO IS ELIGIBLE TO ENTER?

The awards are open to any organisation working in the banking industry who provides one or more of the products listed in our company or partner categories. We also have some non-product specific categories, and categories for journalists and financial influencers. You can view all our categories on pages 8-10.

WHO CAN VOTE?

Customers who are UK residents and aged 18 years and over are eligible to vote in all categories and will be entered into the prize draw. The exception is our award for 'Best Children's Financial Provider', where customers aged 16 years and over can vote.



HOW DOES THE £1,000 PRIZE COMPETITION WORK?

We will randomly select a winner from all customers that leave a valid review during the voting period. Our Terms and Conditions are available by visiting smartmoneypeople.com/ british-bank-awards/terms



ARE EMPLOYEES ALLOWED TO VOTE?

To keep the process fair, employees (or friends and families of employees) are not allowed to vote for the firm they work for.



CAN FIRMS ENTER MORE THAN ONE CATEGORY?

Yes. You may enter as many different categories as you are eligible for. Please speak with a member of our team if you're unsure which category to enter.



CAN CUSTOMERS VOTE MULTIPLE TIMES?

A customer can vote multiple times for different firms, or the one firm, across different categories. If we detect a customer has left multiple votes for the same firm and category only one vote will be eligible.



CAN FIRMS INCENTIVISE CUSTOMERS TO VOTE?

We work hard to make sure that the results of the British Bank Awards are fair, robust and a reflection of the current state of play in the industry. We've honed a robust validation process to spot suspect voting.



HOW ARE WINNERS DECIDED?

Our awards are one of the few awards in the industry solely based on customer feedback. Winners are determined based on the ratings received from the customer feedback, subject to meeting our minimum criteria. All finalist firms are automatically eligible for our 'Best of' and 'Champion' awards.



WHEN ARE THE WINNERS ANNOUNCED?

Winners will be announced at our awards event which will be held in London on the 11th May 2023. Please visit our events page on our website for more information.
